**CUSTOMER AGREEMENT**

- PROPERTIES THAT CONNECT TO "FORCE MAINS" OR ARE LOCATED BELOW OUR SEWER MAINLINES, WILL REQUIRE THE INSTALLATION OF A PRIVATE, SERVICABLE SEWER PUMP, SEWER CHECK VALVE AND ISOLATION VALVE AT THEIR OWN COST. LCRD MUST INSPECT THE HOOKUP PRIOR TO BURYING THE CONNECTION.
- **WASTEWATER PERMITTED USE:** WATER CARRYING HUMAN WASTES, INCLUDING KITCHEN, BATH AND LAUNDRY WASTES FROM RESIDENCES, BUILDINGS, INDUSTRIAL ESTABLISHMENTS OR OTHER PLACES. **IT IS NOT PERMITTED TO CONNECT YOUR ROOF DOWNSPOUTS, EXTERIOR FOUNDATIONS DRAINS, AREAWAY DRAINS OR OTHER SOURCES OF SURFACE RUNOFF OR GROUNDWATER TO A BUILDING SEWER OR BUILDING DRAIN WHICH IN TURN IS CONNECTED DIRECTLY OR INDIRECTLY TO THE PUBLIC SEWER SYSTEM.**
- **RULES AND REGULATIONS:** CUSTOMER WILL ADHERE TO LCRD'S SEWER RULES AND REGULATIONS, AND TO ALL CITY OF CHELAN SEWER CODES UNDER CHAPTER 13.06 "SEWER SYSTEM".
